GENERAL CONDITIONS OF PERMIT:-

1. INDEMNIFICATION

The permit holder agrees to indemnify and to keep indemnified and to hold harmless the Authority, its servants and agents and each of them from and against all actions, costs, claims, damages, charges and expenses whatsoever which may be brought or made or claimed against them or any of them arising out of or in relation to the conduct of the activity.

2. PUBLIC RISK INSURANCE

The permit holder shall possess or take out and keep current a public risk insurance policy insuring for the minimum sum of ten million dollars (\$10,000,000) the Authority and the permit holder against all actions, costs, claims, damages, charges and expenses whatsoever which may be brought or made or claimed against the Authority or the permit holder or both in relation to the activity.

3. MOTOR VEHICLE INSURANCE

If the activity permitted by this permit involves the use of any motor vehicle, such motor vehicle must be insured and such motor vehicle policy shall also have a public risk endorsement for the minimum sum of ten million dollars (\$10,000,000).

4. DISCLOSURE AND EVIDENCE OF INSURANCE POLICIES

The permit holder shall not commence the activity until evidence of such a public risk insurance policy is given to the Authority. Such policy shall bear the endorsement of the Insurer indicating the Insurer accepts the indemnity given by the permit holder.

5. PERMIT HOLDER TO BE LICENSED

The permit holder shall be licensed or registered as appropriate under any laws before carrying out the activity authorised by the issuing of this permit.

6. PERMIT NOT TRANSFERABLE

The permit is <u>NOT</u> transferable.

7. COMPLIANCE WITH STATUTORY REQUIREMENTS

The permit holder shall comply with and give all notices required by any Act of Parliament, ordinance, regulation or bylaw relating to the activity.

8. NOTIFICATION OF DAMAGE

The permit holder must take all reasonable precautions to avoid damage to services, park surfaces, flora and fauna and must immediately notify the Authority in the event of damage to any water, gas, electric, telephone or other service within the area or connected to the activity.

9. EXECUTION OF PERMIT

This permit shall not be executed until the permit holder has received a signed copy of the permit.
